



# Pssst...Have an LA Tax ID?

Did you know that you can keep your tax dollars in our community and support early learners?

For each LA Tax ID,\* you can contribute **up to \$5,000** to the Jefferson Ready Start Network Future Fund and receive a **dollar-for-dollar refundable credit** on Louisiana State taxes as part of School Readiness Tax Credits.

### *How It Works:*

- Complete the School Readiness Tax Credit Contribution Form. Each Tax ID\* can receive credit for up to \$5,000.
- Businesses will receive a donation letter.
- Bring the letter and a copy of your receipt/check to your CPA.
- CPA files Schedule F, 68F credit code on LA state tax return.
- Credit is applied against your LA state tax liability.
- If your contribution exceeds your business's tax burden, then you will receive a check for the difference.
- If any part of your donation is not eligible for the dollar-for-dollar credit, JRSN will provide a refund for the amount of the tax credit not realized.

*\*If you own multiple businesses, you can receive a refundable credit of up to \$5,000 for each business that files an independent tax return. However, if your businesses are set up as flow-through entities, there is a limit of one tax credit (up to \$5,000) per business owner.*
